The collection contains book drafts, manuscripts, outlines, correspondence, photographs, audiocassettes, speeches, interview transcripts, news clippings, notes, and research material. The material relates to Jack Bass' work on *Taming the Storm: The Life and Times of Judge Frank M. Johnson, Jr. and the South's Fight Over Civil Rights*. The materials focus on the life of Judge Frank M. Johnson, Jr., whose judicial career included service on the U.S. District Court for the Middle District of Alabama, the United States Court of Appeals for the Fifth Circuit, and the United States Court of Appeals for the Eleventh Circuit. The bulk of the collection was created and maintained circa 1987-1993, although some of the content dates from approximately 1956-1997.

Creator Information: Jack Bass

Jack Bass was born in 1934 in South Carolina. He was a graduate of the University of South Carolina. He went on to study as a Nieman Fellow at Harvard University and later completed a Ph.D. at Emory University in American Studies. Following a decade of work as a newspaper editor and reporter, he spent two years at Duke University as a research scholar, followed by eighteen months at the Institute of Legal History at the University of South Carolina.

He was twice named South Carolina "Journalist of the Year." Bass has served as a Professor of Journalism at the University of Mississippi and a Professor of Humanities and Social Science at the College of Charleston. Bass is also the author/co-author of several books.
