The material in this collection documents Claire Gregory's work as a Staff Assistant (Intern) at the Freedom of Information Office National Security Council. The collection contains correspondence, memoranda, newspaper clippings, and report. The majority of the material relates to the 1980 campaign. The White House National Security Council (NSC) is the principal forum used by the President of the United States for consideration of national security, military matters, and foreign policy matters with senior national security advisors and Cabinet officials and is part of the Executive Office of the President of the United States. The function of the Council is to advise and assist the President on national security and foreign policies. The Council has counterparts among other national security councils in different nations.

Creator Information: Claire Louise Gregory

Claire Gregory, was born in Winfield, Illinois to the late Cecily and William Gregory. Claire attended Smith College. After her junior year, she was accepted as a summer intern in the Carter White House. She graduated Cum Laude with a degree in government, and went to work for the Department of Energy, Office of Hearings and Appeals in Washington D.C. as a legal and financial analyst. Claire was earned a Juris Doctor from the University of Virginia, School of Law with Order of the Coif honors. Her legal career was singularly focused on ensuring people were treated fairly and received the full protection of the law. As a trial attorney for the Office of the Attorney General for the State of New Hampshire, she advocated for the people of New Hampshire

in civil matters before administrative agencies, state and federal courts. Claire helped the homeless through her commitment to Carpenter Shelter and the Lazarus Ministry.
