## **George D. Moffett Papers: A Guide to His Papers at the Jimmy Carter Library Collection Summary**

Scope and Content:

This collection consists of correspondence, memoranda, notes, speeches, news clippings, transcripts, audio tapes, and published documents. The material relates to George Moffett's research for his dissertation and book on the ratification of the Panama Canal Treaties. In addition to typical research notes and materials, this collection includes material from his Committee of Americans for the Canal Treaties (COACT) office files; White House memoranda made available to him during his service in Hamilton Jordan's Chief of Staff Office; and published hearings on the Canal Treaties before the Senate Committee on Foreign Relations. Due to Moffett's participation in the ratification effort, the collection also contains his reference materials reflecting inside information and interaction with principal players in the treaty debate. Notes of oral history interviews and conversations have been closed in accordance with the donor's deed of gift.

Creator Information: George D. Moffett

George D. Moffett served as Director of Research for the Committee of Americans for the Canal Treaties (COACT), Inc. from the time it was formed in October 1977, until Congress ratified the Canal Treaties in April 1978. He then served as a Staff Assistant to President Carter, and later as Assistant to Chief of Staff Hamilton Jordan. While working in Jordan's office, Moffett was also engaged in research for his doctoral dissertation. In 1981, Moffett earned a PhD in history from George Washington University. He published his dissertation in 1985 under the title, The Limits of Victory: The Ratification of the Panama Canal Treaties. Since 1986, Moffett has worked for the Christian Science Monitor.
