We therefore would like to schedule this meeting with your participation in the last week of May.

We would like to hold an extensive conference with briefings by the Departments of Interior, Energy, Labor, and Agriculture, culminating in your remarks and a brief question and answer session. The meeting would give us the opportunity to publicize our accomplishments in the area of Indian affairs, and for you to announce the formation of an interagency task force on the Rural Policy for American Indians and Alaskan Natives. Most importantly, you would be able to re-affirm your commitment to Indian self-determination.

By late May, Presidential Personnel hopes to have a candidate for the post of Assistant Secretary for Indian Affairs which you also could announce. Even if this position is not filled, to delay the meeting into the summer months would open us to the charge that the meeting is being held for purely political reasons and would diminish its positive impact throughout the Indian community.
