Winston-Salem Fairgrounds Speech

Jim [Hunt], thank you for the introduction.

I couldn't find a better Democratic ticket to run with than right here in North Carolina. I'm proud to run in this Democratic Unity Campaign with Jim Hunt, one of nation's most distinguished governors and a good friend. I'm proud to work with Senator Bob Morgan, Congressman Steve Neal and the rest of the North Carolina Democrats.

And I'll be even prouder when the people of North Carolina vote the Democratic ticket on November 4 -- "from the White House to the courthouse." [this is N.C. Democrat slogan]

North Carolina is my second home. Years ago, the Carters moved from North Carolina to Georgia. They were tobacco farmers here, and for generations we grew up working people

Nashville Town Meeting Opening Statement

When I was growing up in Plains there were two things I wanted to do that I assumed I never would. One was something every Southern boy then knew he could not do. Most were smart enough not to want to -- that is, become President of the United States. The other was something that no Southern boy who ever listened to the radio on a Saturday night could help but want to do -- stand on the stage at the Grand Ole Opry.

I never dreamed at the time that I would have to do the one before I could do the other.

Unlike Georgia, Tennessee has been the home of Presidents for a long time. Everybody remembers a lot of things about Andy Jackson, and everybody remembers the trouble Andrew Johnson had with those Radical Republicans in Washington, but about all the press remembers about President James K. Polk is that he

did not serve alcoholic drinks or allow card-playing in the White House. But President Polk did several things that *are* [were] important to my own life. For one thing, he established the Naval Academy at Annapolis. For another, he let the state of California into the Union. (*As this supposed to be a joke, reference to Reagan? I'm not sure it comes across.*)

I came here to answer your questions, and I am going to do that in just a moment, but first I want to say just a word about something that has been happening lately that worries me.

We have lived under the threat of war almost continually since World War II ended -- under the terrible new threat of nuclear war which could wipe out civilization as we know it. We have said those words for more than a generation, yet we have not yet learned to cope with the terror of their meaning. If we have learned one thing in that time, it is that peace is no accident. War, in all its horror, can be an accident -- a terrible misunderstanding, a critical miscalculation

of intentions or will or capability, a misguided concept of what honor really is. But peace is no accident. It must be won again each day against all the forces willing to sacrifice others for their causes, against all who would gamble with the fate of nations and the world.

People everywhere long for peace, but even at this moment men and women and little children are dying in places all around the globe in wars between nations and within nations, and the peace of all nations is endangered.

The first responsibility of every President is for the security of the nation, and it is a responsibility that is with me every moment. I was trained for nuclear warfare, and I know what it can do. I chose a military career not because I loved war, but because I knew that a strong, well-trained, dedicated and prepared military was the surest way to keep the peace. I have watched the awesome power of nuclear weapons

grow all my adult life, and I am not about to do anything that would risk letting that kind of devastation rain death on any American city.

I am not saying that we fear no challenges, no problems, but the strength of the United States and its Western Allies is unsurpassed and is growing.

We are overcoming the problems we found when I took office.

There was no long-range cruise missile program. Now we have one.

We had no new main battle tank or modern infantry fighting vehicle in production. Now we do.

There was no solution to the increasing vulnerability of our ICBMs. Now there is -- the mobile MX missile.

There was a growing gap in long-range missiles between NATO and the Warsaw Pact nations. Now we are closing it.

There was no comprehensive Allied plan for strengthening our forces in Europe. Now we have a ten-year plan in which all of us -- not just the United States -- are committed to increase our defense budgets.

The state of our defenses is a legitimate subject for political debate. But political candidates make a mistake when they run down America's military strength and try to convince voters that America is weak. In every campaign which charged that the Russians are ahead, the charge has turned out to be false.

A perfect example is the Republican candidate's recent suggestion that we do not have adequate ^{military capabilities} [facilities] to keep open the Straits of Hormuz. With two carrier ^{battle groups} [task forces] and almost 150 aircraft in that region, we have clear naval and air superiority. These aircraft include F-14's which are capable of tracking six enemy aircraft simultaneously and shooting them down.

If, candidates want to contribute to American security,
the most important thing they can do is to talk about our
military strength in a more balanced and responsible manner.

SUBJECT: District Court Decision in Puerto Rico re:
Use of Fort Allen

The District Court in Puerto Rico has issued an injunction against our use of Ft. Allen as a Cuban/Haitian refugee processing center. The basis of the decision was that the President inappropriately used the Federal Emergency Management statute in declaring a state of emergency last May. Further, the judge decided that in any event the emergency declaration of last May was only applicable to the state of Florida and therefore is null and void outside that state.

Justice believes the judge is in error on both counts of his finding and is preparing an emergency appeal to the First Circuit for hearing within the next day or two. Justice will seek an immediate stay of the injunction pending full arguments on appeal.

For your information, the recommendation to use the FEMA authority for declaring the emergency last May was reviewed and approved by Justice, OMB and White House lawyers.

I am preparing a statement for your and Jody's use during your trip. You will undoubtedly be asked about this decision.

Lloyd and I will send a memorandum to all relevant agencies directing that they continue operating all extant refugee centers while the appeal proceeds. Justice has approved such a directive.

We have reviewed your notes and offer the following suggestions:

Business Members

Reg Jones' participation means a great deal to Irv Shapiro. They have discussed the Board and are anxious to make it work. Shapiro thinks there should be two major corporate executives in addition to himself. He is also strongly in favor of both Rohatyn and Dunlop. Since we are not going with either Rohatyn or Dunlop, and because Jones' prestige would add considerably to the stature of the Board, we recommend that you add him.

Since there is no member from the Southeast, you might want to substitute Charlie Zwick for Ted Hagan. This would leave us with one Black person, Coleman Young. Zwick is valuable not only for his financial ability, but also because of his knowledge of government.

Labor Members

Kirkland clearly prefers Lyons and McBride to Glen Watts. He is also strongly in favor of Rohatyn and Dunlop. We agree with you that Watts should be on the Board. If you add Reg Jones, thereby increasing the business group to five members, it would then make sense to keep both Lyons and McBride, giving us five labor members.

Public Members

Betty Furness told us last month that she was anxious to serve. Today, she asked the President of NBC who told her they have a rigid policy which prohibits her from serving. We are working closely with Esther Peterson and will have another woman for you very shortly.

SUBJECT: Percentage of Federal Reimbursement to
State and Local Governments for Refugee
Costs

The legislation the Administration proposed to obtain special status and to establish benefit programs for Cuban and Haitian entrants was not considered by the Congress. Congress enacted, however, the Refugee Education Assistance Act. It authorizes funds for those aliens and makes available \$100 million to reimburse State and local governments for the costs of cash, medical assistance, and social service programs for these people. The Administration's bill proposed reimbursing the States for 75% of those costs. This bill, however, may be used to reimburse States up to 100% of those costs. For Florida, in particular, the issue of the percentage of Federal reimbursement is of transcendent importance.

Our experience indicates that our rhetoric regarding the cost of reimbursement has not kept pace with reality. Our objective was to ensure that State and local governments did not create lavish programs for which we would pay the bills. Our proposal to reimburse those governments at a 75% rate was intended to provide an incentive for those governments to employ effective and cost-efficient programs.

The 75% rate, however, is not crucial to meeting this initial objective, and to continue to insist upon it puts us needlessly at odds with local governments. We can achieve our objectives by working with local governments to agree upon the costs for which we will provide reimbursement. These costs will probably be reimbursed at a 100% level. The legislation making the \$100 million available provides the opportunity to do this because the programs require State plans approved at the federal level. In fact, discussions are already underway concerning which costs are and are not reimbursable.

Therefore, I strongly recommend that you authorize us to proceed on the assumption that we will reimburse state and local governments at 100% of costs which are documented and approved pursuant to agreements between the Federal government and individual State or local jurisdictions. If you approve, we can adjust the approach we initially proposed in legislation to be submitted next year.

Jack, Stu, OMB and HHS concur in this recommendation.

Attached is a letter from Mme. Monique Berlioux, the Director of the International Olympic Committee, enclosing a letter to you from Juan Antonio Samaranch, who has now succeeded Lord Killanin as President. Samaranch is requesting a meeting with you in December during the course of his first official visit to Los Angeles. He is asking to meet "regarding the games to be held in your country in 1984," but he may also bring up the approximately 7 million dollars of payments we have blocked NBC from making to the IOC out of the last 20 million dollars due under its 1980 contract with the Moscow Committee.

Zbig, Chris, Anne and I recommend a brief meeting to close the books on 1980 and assist the Los Angeles Committee to have a successful 1984 games. We also recommend maintaining the blocking order for the immediate future, as security for IOC's good behavior.

Differences over separation of church and state have become the focus of a new and sharp clash between Jimmy Carter and his Republican challenger, Ronald Reagan.

The issue first arose during the recent debate between Reagan and John Anderson, the Independent presidential candidate, when they took opposing positions on the question of evangelical politics and abortion. John Anderson is critical of any interference by religious groups in political affairs. Ronald Reagan has stated that churches should be more involved in political activities and stoutly defends the right of religious organizations to support candidates who express their positions on major public issues.

President Carter believes there should be strict separation of church and state and that the state should not promote any religion to the exclusion of others.

"I don't want to get into a position of personally condemning or criticizing Gov. Reagan," the President said. "But, it is extremely important for us to recognize that there are some things that are important to people all over this country in which the state should not interfere. For instance, Gov. Reagan supports mandatory prayer in school.

"My own belief is that the U.S. Constitution, which lets prayer be a personal thing between an individual and God, not to be imposed by the government at any level.

"As President, I am against the government telling people they have to worship at a certain time and in a certain way. To me, this violates the Constitutional separation of church and state. I don't think the Government should interfere in the right of an American citizen to worship and to worship as he or she sees fit."

The President added: "John Anderson has (at least) three times called for an Amendment to the U.S. Constitution that would identify America as a Christian nation only. This is a very serious matter for most of us who believe this country was founded on the principle

that there should be no State religion -- that the worship of God ought to be a free expression of commitment between that person and God, without requiring that it be within any one particular or exclusive religious tradition."

Although President Carter welcomes support from religious ^{readers} fundamentalists, ^{is a devout Christian,} and ~~considers himself one,~~ he takes exception to others who would attempt to impose one ideology on the entire nation, since this is alien to American tradition.

"I do have ^{deep} ~~fundamentalist~~ personal religious views," he said. "But as President, it is not appropriate for me to attempt to ^{force} ~~impose~~ those views on others who have different beliefs. The genius of America is its respect for diversity and pluralism and its insistence that the government should not foster one religious view over that of another. Jews, Catholics, Baptists and all Americans have an absolute right to freely practice their religious beliefs, without the government trying to foster ~~only~~ one faith in preference to others.

As for Carter's views on abortion, he says, "I am not in favor of a constitutional amendment to overturn the Supreme Court's decision on abortion. Abortion is a sensitive issue. Within the realm of legislation and the action that can be taken by government and by private organizations and by individuals, we should do everything possible to minimize the need for abortions. For example, by encouraging family planning when this is compatible with the family's religious beliefs."

The President added that he is not in favor of federal funds being used to finance abortions.

"I am willing to use federal funds only if the pregnancy is a result of rape or incest or the life of the mother is at stake," he said.

Southern Baptist leader Smith on Jews' prayers not heard by God: "I believe that God hears the prayers of every person and of every religious belief -- Jew or gentile alike," Carter observed. "We all came from one divine creator and He listens equally to all of us."

As for the on-again, off-again debate issue, Carter was asked why he insists on debating only Reagan.

"My feeling is that the Republican and Democratic nominees should debate each other head-to-head without the involvement of any other party," he said, "because the two-party system has been critical to the stability of the U.S.

"Also, it is clear that the nominee of either the Republican or Democratic parties will be the next president. I do not underestimate John Anderson, but he has no chance of being elected president. So, it is important that those who do have a chance of being elected *debate each other directly in order for* ~~be viewed head to head by~~ the American people ~~in order~~ to make an unencumbered judgment of each of the candidates' qualifications *and position on the issues.*

I asked the President for his innermost thoughts as he seeks a second term in the White House.

"This is a tough campaign and an uphill battle," Carter conceded. "What I most want is to tell the people what my Administration has accomplished *what our plans are for the future.* and to set forth the differences between myself and Governor Reagan. Those differences are the most fundamental that have existed between any presidential candidates *in my lifetime, with the possible exception* since the 1964 contest between Barry Goldwater and Lyndon B. Johnson."

Carter gave the following examples:

"Governor Reagan has taken positions against fundamental social legislation such as *Medicare,* Medicare, Minimum Wage, Workers' Safety and Health, Environmental Protection and Aid to Education, with which I fundamentally and totally disagree.

"Governor Reagan also would have our country embark upon what I consider to be a dangerous and ill-founded nuclear arms race to achieve nuclear superiority which no one can win.

"Governor Reagan's economic views are simplistic. The massive, across-the-board tax cuts he proposes, as the answer to every economic ill, are highly inflationary, highly regressive and do not match the balanced program for the revitalization of American industry that I recently announced."

The President added that he is "appalled by Reagan's policy, believing the solution to our Nation's energy problem is to turn loose the major oil companies.

"Governor Reagan is against conservation, and he has beliefs on the amount of domestic crude oil reserves which are not shared by any experts in the area," Carter stated. "He also wants to repeal the Windfall Profits Tax which takes a reasonable amount out of revenues from the oil companies, ^{to be} and used ~~them~~ for public purposes. He is opposed to an expansion of our solar and renewable energy program which is vital to our Nation's security, and he opposes our new synthetic fuel efforts.

"All of the programs he opposes are essential to free the U.S. from excessive dependence on foreign oil."

To decrease our dependence on foreign oil, Carter maintains that he has cut our energy dependence by ^{more than} 20% and that we are moving inexorably toward energy security for the country. *"It is crucial that we not be subject to pressure or blackmail from the OPEC nations"*

"One of my strongest efforts in the last 3-1/2 years is to make our Nation energy secure," he said. "We have put in place the foundation for an energy policy for the 1980's which is now well in place and we expect to add to it in the coming months and years. We are now importing almost 2 million barrels per day less foreign oil than in 1977, when I came to office. And, since then, we have reversed the historic increase in American dependence on foreign oil which I inherited."

President Carter is optimistic that he will be re-elected on November 4th, and gave three reasons for his confidence:

(1) "Both unemployment and inflation are coming down. 1981 will be the year that we will come out of our recession with a good recovery, which will continue to reduce unemployment as we continue to work on our problem of inflation."

(2) "I've been able to get most of my major legislation through Congress, in particular to deregulate airlines, trucks, and rails and to help make our Nation energy secure."

(3) "The shortcomings of Mr. Reagan's positions, ^{on} which the public will soon focus ~~on~~ as the election draws near."

He added that Reagan has taken some "extraordinarily erratic and extremely conservative" positions on foreign and domestic affairs over the last 16 years.

"I don't think his positions represent the mainstream of America's beliefs," Carter concluded. "He has opposed some of the essential social advances, like Medicare and the Minimum Wage, and has taken positions on foreign affairs which are ill-founded.

"He has suggested that American troops be sent to a number of different countries; his solution to the Afghanistan crisis was to blockade Cuba; and he would involve our country in an unwinnable effort at nuclear superiority."

which takes a ^{reasonable} ~~reasonable~~ amount out of revenues from the oil companies and uses them for public purposes. He is opposed to an expansion of our solar and renewable energy program which is vital to our nation's security, and he opposes our new synthetic fuel efforts.


He added that Reagan has taken some "extraordinarily ~~is~~ erratic and extremely" conservative positions on foreign and domestic affairs over the last 16 years.


